The brainstorming group has been considering the applicability of [The Sedona Conference International Litigation Principles](#) to international arbitrations involving cross-border transfers of data and associated data protection and cross-border discovery and disclosure issues, and whether an appendix to the [International Litigation Principles](#) would be appropriate or whether a stand-alone publication might be preferred.

A panel of WG6 drafting team members will lead a dialogue on their second draft of a Commentary on the topic. The dialogue will focus on the clarifying principles and proposals to guide decision-makers in resolving choice of law issues with respect to data traveling across international borders, as set forth in the draft Commentary.

**11:00 — 12:00 Ephemeral data**

A panel of WG6 brainstorming group members will lead a dialogue with all WG6 members in attendance on their outline on the topic. The brainstorming group has been exploring whether WG6 should prepare a Commentary and/or develop best practices on ephemeral data issues in cross-border legal actions and investigations. Organizations and individuals commonly use ephemeral communications and often view doing so as appropriate and helpful to address data minimization requirements under data protection frameworks, including the European Union General Data Protection Regulation (GDPR). However, capture and preservation of ephemeral data to meet legal obligations presents unique challenges. The brainstorming group has been assessing these tensions and preparing recommendations.

A panel of WG6 brainstorming group members will lead a dialogue with all WG6 members in attendance on their outline on the topic. The brainstorming group has been exploring whether a standalone publication on international legal holds would help move the law forward in a reasoned and just way by supplementing existing publications, including [The Sedona Conference Commentary on Legal Holds](#) (prepared by The Sedona Conference Working Group 1), which only issue spots re international legal holds, and [International Litigation Principles](#), its appendix on Cross-Border Data Safeguarding Process + Transfer Protocol, and [The Sedona Conference Practical In-House Approaches for Cross-Border Discovery & Data Protection](#), which focus on the entirety of the life cycle of cross-border discovery matters rather than focusing on issues arising solely from the legal hold process.

A panel of WG6 brainstorming group members will lead a dialogue with all WG6 members in attendance on their outline on the topic. The brainstorming group has been evaluating whether WG6 should prepare and publish a Commentary, or otherwise identify best practices, to prepare companies for dawn raids or other criminal investigations that may involve multiple jurisdictions. To the extent this project extends the work started by [The Sedona Conference International Investigations Principles](#), it will probe more deeply into information germane to criminal law practice and procedure.

The draft Commentary aims to provide guidance on how the concerns raised by a preceding brainstorming group on the International Standards Organization (ISO) Code of Practice for Electronic Discovery (ISO/IEC 27050: Part 3) ("ISO Code of Practice") can be minimized – if not avoided altogether – while acknowledging that some organizations may seek certification of compliance with the ISO Code of Practice.
